If you have statements from the youth members who you interviewed, we would appreciate these for our files. This certainly adds strengthening factors to our file, and makes refusal of registration in any other location much easier.

I am enclosing a confidential record sheet, which we would like to have completed and signed. This will help us in future identification, if registration attempts take place.

We certainly appreciate all the work you did and hope you will tell us of any more information which becomes available. I'm assuming from what you told me, that this individual was not charged in any of these situations. If he has been, then we would need the outcome of any legal action which took place.

In late August of this year I was contacted by Dr. George W. Chambless, Committee Member of Troop 229, Lexington, N.C. Dr. Chambless informed me that the Scoutmaster of Troop 229, James D. Barton, Jr. had resigned his position when approached concerning allegations of sexual misconduct.

In the course of further investigation I interviewed Mr. David T. Driver, Jr., Scoutmaster of Troop 211, Lexington, N.C. Mr. Driver statement is enclosed.

I then interviewed two Scouts, age 15 and 16, who were members of Troop 229. The boys were interviewed separately but in the presence of Mr. Driver. Both scouts related instances of sexual fondling and one reported an instance of oral sex between he and Mr. Barton.

I strongly recommend that Mr. Barton be placed on the Confidential List and be allowed no further association with the Scouting program. Identification information on Mr. Barton is included on an enclosed sheet.

If you desire further information please let me know.

VED IN SCOUTING CONCERNING THE ACTIVITIES OF JAMES D. BARTON JR.

APRIL 17, 1983

THE FOLLOWING COMMENTS WERE RECEIVED FROM CAMP UMHARRIE ON
CONCLAVE TO A 14 YEAR OLD SCOUT WHO I LIVED ALONG WITH FROM
LEONARD C. WOOD (2E) AT THE TIME HE WAS BOY SCOUT LEADER.

JUNE 13, 1983

I LEFT TWO 15 YEAR OLD BOYS WITH JIM BARTON TO COMPLETE THE
FIXING OF A BUNKER ALARM IN THE BASEMENT OF A BOY'S HOME IN
LEONARD, VA. AFTER 45 MINUTES AFTER I FOUND THE BOYS SITTING
IN THE GARAGE INSTEAD OF DOING THEIR WORK. WHEN I ASKED THEM
WHY THEY WERE NOT DOING THEIR WORK HE ANSWERED THAT HE WAS
DRESSING AS A BOY SCOUT LEADER BE CAUSE HE WAS TELLING ME
TO BE SCOUT AND I WAS ASKING HIM TO LEAVE ME ALONE. IF YOU WANT
ME TO BE YOUR FRIEND YOU HAVE TO BE AT HOME.

JUNE 19, 1983

BOY SCOUT TROOP 1118 2037 CAMPED OVERNIGHT AT CAMP UMHARRIE ON
THE WAY TO PHILMONT BOY SCOUT CAMP IN NEW MEXICO. JIM BARTON AND A 15
YEAR OLD SCOUT STARTED TO TAKE A SHOWER TO GET THE BOY'S HAIR AND TO
SHOWER. MY SENIOR PATROL LEADER SAID MR. BARTON AND I GO ARE ON
THE WAY TO TAKE A SHOWER. DON'T YOU THINK WE NEED TO TAKE ONE TOO.
HE REPLIED THIS IS DEPENDS ON THE TIME. WHEN THE BOY ENTERED
THE SHOWER HOUSE FIRST HE AND I SAW THE FOLLOWING THE BOY
STANDING UNDER THE SHOWER WITH A COMPLETE ERECTION AND JIM BARTON
NEXT TO HIM. THE BOY WAS SAYING LEAVE ME ALONE SO I CAN TAKE A
SHOWER. AND HE PUSHED HIM AWAY. THE SPL COMMENTS MR. DRIVER, IT
LOOKS LIKE YOU WERE RIGHT MR. BARTON COULD BE GREAT.

JULY 1, 1983

(IN LOS ANGELES), CALIFORNIA IN A PHOTODUOR AT UNIVERSAL STUDIOS. A
BOY GOT HIS FINGER AND NEEDED A BAND AID. I WAS THE SCOUTMASTER
TO TAKE CARE OF HIM WHILE HE WAS IN THE PHOTODUOR. HE SAID
AND I MADE SEVERAL COMMENTS TO HIM. HE SAID HE WAS A SCOUTMASTER



AUGUST 3, 1988

THE BOY BEGAN TO GET BITTE FROM ME WHEN HE BECAME TO OLD (15TH) AND HE WAS ASK TO HELP ME BARTON GET CHAUNT UP ON COMPUTER WORK. THAT HE WAS BEHIND ON BECAUSE OF THE PRILMONT TRIP FOR TWO TRIPS TO THE COMPUTER ROOM WITH THE THE PROMISE OF RECEIVING \$3.00 PER HOUR FOR HELPING WITH BARTON PERFORMED ORAL SEX ON THE 15 YEAR OLD BOY. THE BOY TOLD ME SEVERAL TIMES HE WANTED TO TALK TO ME AND FINALLY HE BROKE DOWN AND TOLD ME THE WHOLE STORY WHICH I BELIEVE.

UPON CONFRONTING BOY BARTON WITH THE FEWE HE SAID HE WANTED TO RESIGN WITH MINIMAL PUBLICITY FOR WHICH I BELIEVE WOULD BENEFIT SCOUTING AND SINCE THE PARENTS WILL NOT PROSECUTE BECAUSE OF EMBARRASMENT AND SINCE BARTON IS NO LONGER ASSOCIATED WITH THE BOY SCOUTS OF AMERICA I AGREE.

UPON TALKING WITH SEVERAL BOYS AND OLD I BELIEVE THE ENCLOSED APPROXIMATE TO BE TRUE AND ACCURATE.
