

I feel it is necessary to record a past experience and to prevent future problems regarding the abnormal behavior of an Eagle Scout and now assistant scoutmaster by the name of Michael Brown.

During the fall Camporee of 1983 located at Camp Woodland I attended as a parent assisting the Scoutmaster. On that Saturday night I shared a cabin tent with Scoutmaster Rowe and Scout Michael Brown. During that night I was awakened by the attempts of Scout Brown to enter my sleeping bag with his hands. I shoved him away and asked what he was doing, I received no answer. The following morning I attempted to ask again what his problem was and he answered that he was an epileptic and sometimes had restless nights.

I have kept my suspicions to myself until this past week when a committee member mentioned that other more serious incidents have occurred regarding this person's behavior.

Please take action accordingly.

My name is [REDACTED] and I
am Committee Chairman for Boy Scout Troop #724
of Constantia, New York. A problem has arisen in
our troop which needs immediate attention.

Enclosed you will find two letters
detailing at least two instances in which an
Eagle Scout, now Asst. Scoutmaster, has made
advances towards other men in our troop. I
was also informed two weeks ago of a situation that
occurred three years ago between this same Eagle
Scout who is now eighteen years old and a Boy
Scout who was eleven years old at the time. This
situation happened on a week long camp out. This Eagle
Scout cornered this eleven year old boy and physically
grabbed the boy by his private parts.

Because of this incident and the two statements
enclosed I feel it would be in the best interest of
the troop and the Boy Scouts of America if this Eagle
Scout whose name is Michael Brown of the Salt Road
in Constantia, New York be removed from the Boy

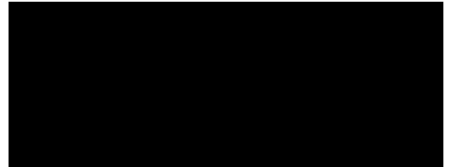

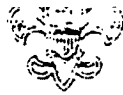

Dear Don:

We recently discussed Michael Raymond Brown and the potential confidential file case. I agree with you that this case is not too strong, since all we have are statements from some individuals which indicate that Michael Brown's judgement has been very poor in his relations with others. It is possible that this would be adequate to refuse registration, but I feel that it is a borderline situation. You certainly can refuse registration in your council, since he apparently is not accepted as a leader among the other Scouters in that particular area.

I would recommend that we place him on a probationary basis and try to refuse registration if possible, but at least inform the Scout Executive of any council where he may try to register.

If this is satisfactory with you, please let me know. In the meantime, if you can secure anymore information we would appreciate this.

It would be most helpful to have additional information if this can be secured. The information which you have presently sent us does not indicate that sexual acts of any kind actually took place.
