It was reported that homosexual approaches had been made with the boy observing said act on more than one occasion as well.

A confidential meeting was held with Mr. Allen, Don Ball, Field Director, and Bill O'Geary, District Executive, at which time, said act in question was admitted by Mr. Allen. Mr. Allen subsequently resigned from the troop and has recently moved from New Port Richey to the Orlando, Florida, area.

Mr. Allen is single, a disabled veteran and resides with his mother. Mr. Allen is 41 years old.
