at Mr. Robert Curtis' request,
I am writing about my work
with him from August 1966 to the following February.
I am a practising psychiatrist and saw Mr. Curtis
in outpatient psychotherapy during that
time.

Mr. Curtis' emotional symptoms were primarily
anxiety and depression. In my opinion a
broken home, his speech defect, and the death
of his girl friend predisposed him emotionally
to the isolated instance which resulted in his
expulsion from the Boy Scouts of America.

This expulsion was traumatic to Mr. Curtis since
his long association with the organization was
an important part of his life. He is very hopeful
that he can be accepted, in some capacity, for
further boy scout work. During the time he
worked with me he was well-motivated, cooperative,
sincerely concerned about his problems.

When I discharged Mr. Curtis over a year ago,
I considered his prognosis to be good. It is
my understanding that his ability to function
effectively at work, within his family, and to some
extent socially has been maintained.

I hope you are able to consider Mr. Curtis' petition at
this time, and that my statement will be of some help.

TO WHOM IT MAY CONCERN:

My NAME IS ALEXANDER B. McELWEE OF DARIEN, CONN. I FULLY REALIZE THE SITUATION AND THE PARTICULARS INVOLVED AND WOULD LIKE YOU TO BE MOST CONSIDERATE IN YOUR FINAL APPRAISAL AND DECISION IN THIS CASE. IN EXAMINING ALL THAT IS ON REPORT, I THINK ROBERT "SKIP" CURTIS SHOULD BE GIVEN AN OPPORTUNITY TO FULLY EXPLAIN HIS PORTION IN DETAIL AND CONSIDERATION BE GIVEN TO ALL HIS YEARS IN SCOUTING, ALSO TO ALL HIS EFFORTS TO FURTHER THE SCOUTING MOVEMENT IN THIS AREA. THROUGH LOCAL INVESTIGATION YOU WILL FIND ONLY PRAISE FOR THE TIME AND EFFORT "SKIP" CONTRIBUTED TO SCOUTING AND THE TROOP (60) FROM WHICH HE WAS CASHIERED.

My ASSOCIATION WITH SKIP HAS BEEN THROUGH ANOTHER SOURCE ^{WHICH} ~~ONCE AGAIN~~ DEALS WITH YOUNG AND IMPRESSIONABLE BOYS, AND THAT IS "LITTLE LEAGUE," WHICH IS ALSO NATIONAL IN SCOPE. "SKIP" HAS BEEN A COACH AND MANAGER FOR TWO SEASONS NOW, AND HAS SHOWN THE QUALITIES OF LEADERSHIP AND SPORTSMANSHIP WHICH IS SO HARD TO ATTAIN WITHIN A PROGRAM THAT IS STRICTLY ADULT PARTICIPATION, ONLY ON A VOLUNTARY BASIS.

As a adult scoutmaster I am fully aware of the moral code of the B.S.A. and do not condone immoral activities. However, I believe this affair was not premeditated or practiced beyond this instance. My personal feeling regarding this situation is that Mr Curtis has more than paid his debt to society. He immediately solicited physiological help and has adhered to this advice.

With due respect to you and the B.S.A. I would think it grossly unfair to reject Mr Curtis' application for reinstatement.

I firmly believe the Boy Scout movement was intended to be and is a basis for support and guidance for the young males of the world.

Mr Curtis has been a guide to many boys for several years. It would seem unjust in my small opinion to have this guidance stop because of one mistake, therefore, I am appealing to you to for serious consideration of Mr Curtis' reinstatement

Thanks for your kind cooperation.

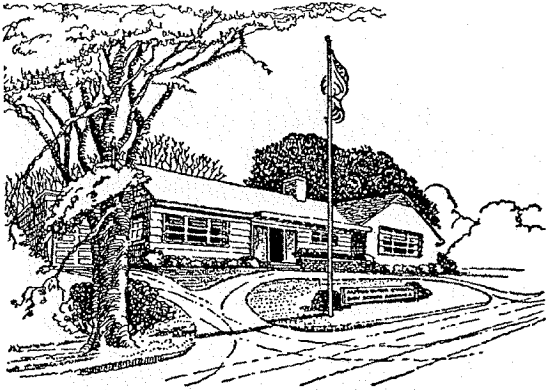

HE CAME IN THE OFFICE WHEN I WAS OUT AND WANTED THE NAME OF THE PRESIDENT OF THE BOY SCOUTS OF AMERICA. HOWEVER, ED CHRISTOPHERS WHO WORKS WITH ME NOW AS DISTRICT EXECUTIVE, EXPLAINED TO HIM THAT THIS WAS FOOLISH, AND HE THINKS HE HAS DISUADED HIM.

██████████, CHAIRMAN OF TROOP 60'S BOY ██████████ IS THE ONE THAT WAS OFFENDED. DUNN AND I TOLD MR. ██████████, SO WE GOT THE STORY FROM HIS SON - NOT HIS FATHER. ██████████ TOLD ██████████ AND ██████████, SO IF YOU WISH ANY STATEMENTS, I THINK THEY SHOULD COME FROM THESE TWO.*

THEY ADMIT TO A "BLOW" JOB AT CAMP TOQUAM IN DECEMBER 1965 ON THE FLOOR OF THE PACK BUILDING: ONCE IN THE ██████████ HOME WHEN THEY WERE PUTTING AWAY TENTS: AND ONCE IN CURTIS'S CAR. ██████████ INDICATES THERE WAS ANOTHER JOB ON SUNDAY, AUGUST 7 WHEN THEY CHECKED IN TO CAMP, AND WHEN A POLAROID PICTURE WAS TAKEN OF ██████████ ERECTION - HOWEVER, CURTIS DENIES THIS.

This additional information will enable us to identify Mr. Curtis should he ever again attempt to register in the Scouting program.

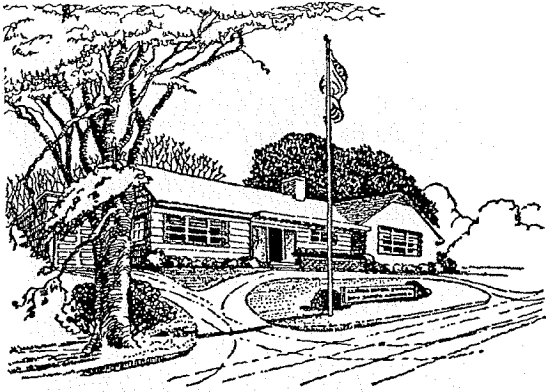
