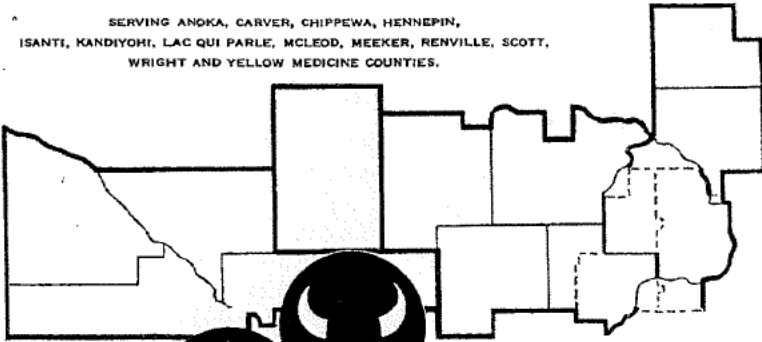


Dear Howard:
