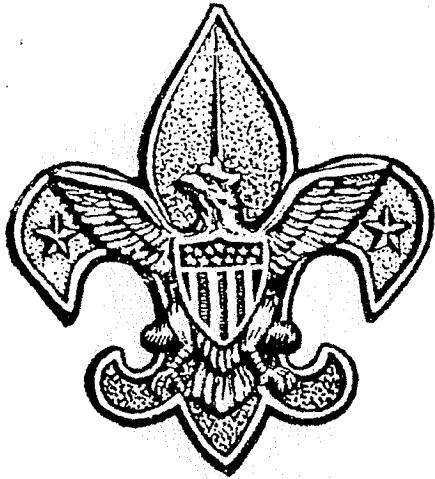


Dear Dr. Wilson:

For the first time in my experience, and I hope the last, we find that we must recommend the plaging of a Scoutmaster on the "confidential file." This person admitted "molesting" a boy, and recounted unnatural acts while stationed in Japan some few years ago.

He is Sgt. Zachary D. Andrews, registered as Scoutmaster of Troop 210, Montgomery, Alabama. He is being discharged from the U. S. Air Force because of this disgusting experience. He is 37 years of age, and unmarried. He had previously served in Scouting in other councils.

If additional information is needed, I'll be glad to provide it, for this person has wrought enough damage already to Scouting and must not be permitted to register again.

I am very sorry that you have found it necessary to send this information about Sgt. Andrews. We will place your letter in our file. If we are to follow up your request, to check registration in the future, we must have an accurate description. I am enclosing a confidential record sheet for your use, to provide us with this description. Please return it as soon as possible and mark it PERSONAL AND CONFIDENTIAL.

The years have a way of clouding situations and we are often faced with the problem of scanty information when we must deny registration. So, if you are able to give us additional information, it will be placed in the file for the guidance of those who may sit here years from now. We have found some Military very cooperative, perhaps they will give you a copy of the charges against Sgt. Andrews, or if you could secure a statement from the boy or the parents of the boy, this will be helpful. You can assure people giving you statements, that such information is kept under lock and key and shared with no one except the Director of Registration. We are always more sure, when we check a registration if we have good strong material on file.
