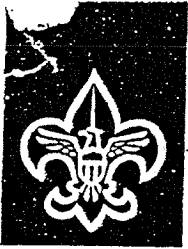

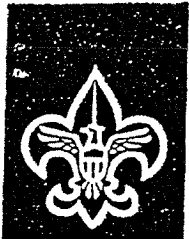

We have finally had a letter from the Troop Committee of Troop 82, Bucksport, plus an indictment by the Grand Jury relative to former Scoutmaster Harold Bailey of Bucksport.

We recommend, although there has been no conviction at this point, that Harold E. Bailey, 13 Second Street, Bucksport, Maine (P.O. Box 419) be placed in the confidential file, due to alleged homosexual activities with several members of Troop 82.

Mr. Bailey is 51 years old, about 6 feet tall, grey haired, is single (never married), and is employed by St. Regis Paper Company. He is an Air Force veteran, having retired with the rank of sergeant. His weight is approximately 170-175 pounds.

If we have any other personal data on him, I will let you know.

COUNT I

THE GRAND JURY CHARGES:



The case is now before the Hancock County Grand Jury.






